**REQUIREMENTS REGARDING THE SCIENTIFIC PAPERS**

**PAPER FORMAT**

The Scientific committee reserves the right to refuse acceptance of papers not falling under the Conference thematic area, papers that do not comply with the scientific evaluation assessment (proper scientific level, actuality of the topic, novelty compared to the existing doctrine, relevance of the cases analyzed, paper content according to the legislation in effect at the moment of submission) or papers not reviewed and rewritten within a reasonable time, according to the observations and suggestions of the Scientific committee.

- The content of the study will be written in the *Romanian* and, respectively, in the *English* language;
- The studies will be between minimum 7 pages and maximum 9 pages long;
- The title of the paper will be in *Times New Roman*, size 14, left-aligned;
- Two rows (size 12) down from the paper title, will be written the full first name and name, in *Times New Roman*, size 12, bold, left-aligned; only the name will be written with capital letters;
- After the name, a star will follow and in the bottom of the page there will be indicated the scientific title or, as the case may be, the profession and, for both, the affiliation;
- After the name, two rows (size 12) down will be written the **abstract** (max. 150 words – the abstract must emphasize the topic approached in the article and will contain no quotes or other published works) and under it the **key words (3-5)**, in *Times New Roman*, size 10, 1 row distance, *justified*-aligned;
- The content of the paper will be two rows (size 12) down from the key words and will be written in *Times New Roman*, size 12, 1.5 rows distance, *justified*-aligned.
- Page A4: (Setup: Top – 2 cm, Bottom – 2 cm, Left – 3 cm, Right – 2 cm);
- Footnotes will be written in *Times New Roman*, size 10, 1 row distance, *justified*-aligned;
- Bibliography – at the end of the study, in *Times New Roman*, size 10, 1 row distance, *justified*-aligned;
- For underlining in the text, only the *Italic* font will be used, not the **bold** or underline;
- The bibliographic references have the form: Author (author’s initial of the first name and surname – without bolded fonts), *Title*, publishing house, place, year, page. The mention of the page: „p.“, when it involves a single page, „pp.“, when it involves several pages. Indications in Latin (*idem*, *op. cit.*, *ibid.*, *sq* etc.) with *Italic*. In a bibliographic list, each entry ends with a period.
- For the bibliographic references sending to periodical publications, the entries will have the form: Author (author’s initial of the first name and surname), complete title of the article (in *Italic* and without quotation marks), *Publication name*, number, year, p. (pp.) xx-xx. In the same form will appear references to chapters of books or to contributions in collective works: Author A, „Chapter quoted“, in Author B (coord./ed.), *Paper title*, publishing house, place, year.
